



CHILDREN'S CONSIGNMENT

Consignment Agreement

- **Consignments** will be taken during store hours if space is available. Notice will be posted if the store is full at that time. There is a **limit of 2 bags per customer at one time**. Large items will be taken in addition if they are in clean, working condition. Incomplete items or item subject to recall cannot be accepted.
- **ALL Clothing** must be clean, laundered, stain-free, rip/hole-free, and of current fashion. Clothing must be folded and nicely laid in the bags. Clothing will sell best if brought in according to seasons. Bubbles & Bean, Inc. reserves the right to not accept items that do not conform to our Consignment Standards. All items not conforming to our standards will be donated without notice to the consignor. IF dropped off bags require extensive stain sorting of over 25% of the bag a fee will be assessed onto the consignors account, depending on the size of the bag. IF an item requires extensive cleaning, or testing, a 10% of sale price fee could be assessed. _____(initial)
- **90-Day Consignment Period** for most consignable items. Items remaining over 5 days past the end of the duration are the property of Bubbles & Bean, Inc. to donate. We never donate "significant" large items without prior notification. _____ (initial)
- **Pricing of consigned items** is set by Bubbles & Bean, Inc. Prices are set according to condition, brand, style, size and demand. Bubbles and Bean, Inc cannot guarantee a 'set' price for a certain item.
- **Sale or Discount of Consigned Items** may be placed at the discretion of Bubbles & Bean, Inc. (i.e. end of season, holiday sale, or special event)
- **Payout Options** (select one option)
 - BE A BUBBLE BUDDY!!** Bubble Buddy Members earn 50% Store Credit on consignments to be payed onto the consignors account at the end of every month. Account balance must be used as Store Credit. Store Credit will never expire. Account balances will not be payed out by check or cash. _____(initial)
 - Cash or Check Payout:** earn 40% on consignments in either store credit or cash/check. If balances are over \$30 a check must be issued with a \$1 check fee. Accounts will be assessed on a monthly basis and any monies accrued over \$50 must be payed out in one form or another. A personal note will be sent to you for direction. _____ (initial)
- **Bubbles & Bean, Inc.** will not be responsible for loss or damage to items consigned for any reason including theft, natural disaster, vandalism, fire or water. A 3% buyers fee will be assessed on all items bought.

I UNDERSTAND AND AGREE TO THE TERMS OF THIS AGREEMENT:

Consignor represents and states that he/she is the owner of all items placed for consignment and that the goods are salable and/or free of any liens or other claims. Consignor also understand the Bubbles & BEAN, Inc reserves the right to reject any item brought in for consignment.
